RESOLUTION

WHEREAS, pursuant to Iowa Code section 298A.10 and section 281 IAC 98.68 of the Iowa Administrative Code an Iowa school Board can authorize the transfer of funds from the debt service fund to the PPEL Fund when funds remain in the debt service fund after payment of the entire balance of outstanding debt in accordance with the original purpose of the bonded debt, and

WHEREAS, the West Hancock Community School District Board finds that there is a current balance of \$74,163.89 in the District's debt service fund which is no longer necessary for the original purpose of paying off bonds as all such bonded indebtedness has been paid.

BE IT THEREFORE RESOLVED AS FOLLOWS: The Board of Directors of the West Hancock CSD declares that the current balance of \$74,163.89 in the debt service fund and any interest later accruing is no longer needed for the payment of outstanding bond debt.

BE IT FURTHER RESOLVED that the West Hancock CSD has a need for the use of such funds in its PPEL fund and thereby authorizes the immediate and permanent transfer of such surplus funds to the District's PPEL fund. Motion by: Burgardt Second by: A. Johnson

Motion by Deutsch, seconded by Abels, to approve the modified allowable growth for dropout prevention/At-Risk not to exceed \$169,812.00. Carried 7-0

RESOLUTION(1)

Whereas, Iowa Code section 298A.2 currently provides Iowa school districts with enhanced flexibility to transfer eligible funds under certain conditions to be spent for other specified purposes, and Whereas, the West Hancock CSD Board wishes to establish a flexibility account within the District's general fund and to transfer into it a portion of the unexpended and unobligated funds from its approved local program under the statewide preschool program for four year olds per Chapter 256C Iowa Code.

NOW THEREFORE BE IT RESOLVED:

1. The Board finds that \$40,000 should be transferred from the FY 2019 year end fund balance in its four year old preschool program.

2. Further the Board finds that said funding remains unexpended and unobligated after providing preschool programming during the FY19 fiscal year to all eligible students for whom a timely application for enrollment was submitted.

3. The Board also further directs its Superintendent and Board Secretary to arrange for publication of a notice in a manner as required by Iowa Code of a public hearing to be held at its January 2020 regular meeting on a resolution proposing to expend any and all funds from the District's new Flexibility Account for any school district general fund purpose in order to provide or support quality education for the students of the District as determined by the District's Board and Administration.
