USDA Nondiscrimination Statement Information

The lowa Department of Education expects all informational materials (web sites, meal eligibility applications, letters of notification and elsewhere as applicable) used to inform the public about FNS programs to contain the full USDA nondiscrimination statement. The font size of the statement must be at a minimum eleven with the format as below.
